What will it involve?

The ACCA Diploma in Accounting and Business consists of seven exams and an online ethics module. We recommend that the exams are taken in the following order, for which you receive interim awards along the way:

- ACCA Introductory Certificate in Financial and Management Accounting (RQF Level 2): The first two exams cover some essential basic principles: Management Information; and Recording Financial Transactions.
- ACCA Intermediate Certificate in Financial and Management Accounting (RQF Level 3): The next two exams build on your essential knowledge of financial transactions: Maintaining Financial Records; and Managing Costs and Finance.
- ACCA Diploma in Accounting & Business (RQF Level 4): The final three exams are: Business and Technology; Management Accounting; and Financial Accounting.

Once you have completed all the above and passed the online ethics module, Foundations in Professionalism, you can then transfer to the ACCA Qualification, starting with our Applied Skills exams.


